- 2 Canceled Booking but No Refund** Many travelers cancel flights or hotels within the allowed window but never receive their refund. This is one of the most common dispute reasons.
- 3 Duplicate or Incorrect Charges** Being charged twice for the same reservation or billed more than the agreed amount can justify a dispute.
- 4 Service Not Provided** If a hotel, airline, or car rental provider failed to deliver the service (for example, the hotel was closed or the flight was canceled without rebooking), you may be eligible for a refund.
- 5 Misleading Booking Details** If the actual service significantly differs from what was advertised (wrong room type, hidden fees, missing amenities), you can raise a complaint and request a charge review.

How the Southwest Dispute Process Works When you initiate a dispute, Southwest follows a structured review process:

- Initial Contact** Start by contacting Southwest customer support at **1-866 →829 →1265(USA)** or **44-203-868-6110 (UK)**. Provide your itinerary number, booking details, and a clear explanation of the issue.
- Investigation With the Vendor** Southwest will open an investigation with the airline, hotel, or rental company to confirm the claim.
- Temporary Credit (If Applicable)** In some cases, you can quickly call **1-866 →829 →1265(USA)** or **44-203-868-6110 (UK)** (Direct) to ask whether a temporary credit can be issued while the dispute is under review.
- Resolution or Denial** After reviewing evidence from both sides, Southwest may approve a refund, issue a partial credit, or deny the dispute based on fare rules and vendor policies.

Timeline Disputes can take anywhere from a few days to several weeks, depending on the vendor's response time.

Can You Dispute an Southwest Charge Through Your Bank? Yes If Southwest cannot resolve the issue, you may contact your bank or credit card issuer to file a chargeback. However, Southwest generally recommends trying to resolve the dispute directly with them first.

Important things to note before filing a bank dispute: A chargeback may take 30–90 days. Southwest may suspend future bookings during the investigation. You'll need documentation (emails, receipts, cancellation confirmations). Calling **1-866 →829 →1265(USA)** or **44-203-868-6110 (UK)** before initiating a chargeback
