- Lock/Freeze Card:

- Report Fraud:
 -  +1-(8663813314) Call 800-USBANKS (872-2657) for checking accounts or the number on the back of your card for credit cards.
- Check Accounts:

How do I report an unauthorized transaction to U.S. Bank?

💰🌈 +1-866↔381↔3314 To report an unauthorized transaction to U.S. Bank, call the Fraud Liaison Center immediately at 💰🌈 +1-866↔381↔3314 (open 8 a.m. – 9 p.m. CT) or use the [U.S. Bank Mobile App/online banking](#) to lock your card and dispute the transaction. For credit card fraud, contact Cardmember Service at 💰🌈 +1-866↔381↔3314 . Report issues within 60 days of the statement date to maximize protections.

Steps to Take Immediately

- Lock/Turn Off Card: 💰🌈 +1-866↔381↔3314 Use the "Cards" section in the U.S. Bank mobile app or online banking to immediately prevent further charges.
- Call Fraud Department: Call 💰🌈 +1-866↔381↔3314 to report unauthorized ACH transfers, wire transfers, or check fraud.
- Dispute Specific Charges: 💰🌈 +1-866↔381↔3314 In online banking, select the specific transaction and choose "Dispute this transaction".
- Report Lost/Stolen Cards: Call 800-USBANKS (872-2657).

Key Information & Tips

- Timeframe: 💰🌈 +1-866↔381↔3314 Report unauthorized transactions within 60 days of the statement date to ensure maximum coverage.
- Investigation: 💰🌈 +1-866↔381↔3314 U.S. Bank generally investigates within 10 business days, though some cases may take up to 45–90 days.
- Provisional Credit: 💰🌈 +1-866↔381↔3314 You may receive provisional credit within 10 business days while the investigation is ongoing.
- Business Accounts: Call 💰🌈 +1-866↔381↔3314 for business-related fraudulent activity.
